APPROACH

We strongly believe that Voluntary sector in India is the unrecognized fifth pillar of democracy, and we are consciously working for its recognition as such.

Democracy stands on four pillars; Justice, Equity, Freedom and Representation to all its citizens, and to ensure this, checks and balances were introduced by the conventional modern societies initiated by the British. We grew up in India reading that the Legislature, Executive and Judiciary were the three Pillars of our democracy. The Media became strong during the seventies emergency movement as a watch dog and Press assumed its role as the fourth pillar of Indian Democracy. They are in place to ensure the rights and freedoms of all people in Indian society. All the four pillars have set and assumed their roles as under; (i) Legislature is constituted by people's representatives directly elected by the public to make laws keeping public welfare in mind; (ii)

Executive is the cabinet based on the principle of joint responsibility. It implements a political party's Policies and program and (iii) Judiciary ensures that Rule of Law prevails.

Implementation of the decisions by all above three wings is through Bureaucracy which ensures that the policies, programs and judicial orders are implemented through Public service approach. The Media represent public sentiments and opinion on the working of all the other three entities. It has assumed the role of 'Fourth Pillar' in our democracy. In ideal conditions this entity occupies a unique position of keeping the other three in check. The media let the public know what is going on and provides public opinion to the 'Rulers'. A biased reporting may result in upsetting the balance.

Over the period of last 68 years since our independence the public has realized that the existing four pillars of 'Democracy in India' have not been able to deliver the promises made to people at large. The Legislature is based on caste and region based political party system wherein the elected representatives have electoral compulsions which deter the parliament to think and act collectively in the larger interest of the society and the country. The larger issues of the society like; land rights, forest rights, women representation, equitable development, corruption, etc are never pushed forward. The executive structure has become too heavy and corrupt that it gulps all the development funds on its own structural maintenance. Services are created more to protect the existing executive rather than to serve or develop. Even the sincere efforts do not reach at the grassroots level. The higher Judiciary has been providing a spark despite occasional allegations of 'Judicial Activism' but the lower judiciary is again inefficient, overloaded and allegedly corrupt. Media, the only watchdog enjoyed its celebrated status till the end of nineties and today it is as good as the India Incorporation. In the business world only the saleable is heard and the genuine concerns of majority among our down trodden society are never heard. The society at large feels alienated. Despite all claims by the successive governments the last man has never had his fill of promises, and the last man here stands for millions of deprived human beings who do not have any one to help support their claim.

This dim scenario opens the gates for another front which not only acts as a watchdog but also provides constructive support to the executive to reach the last man. The voluntary sector is also known as the Non-government sector or the civil society or the community sector, due to its direct outreach to community at large. The presence of a large non-profit sector is rightly seen as an indicator of a healthy economy in local and national financial measurements across the developed nations. With a growing number of non-profit organizations focused on social services, the livelihoods, environment, education and wellbeing of the society, the non-profit sector is increasingly becoming central to the health and well-being of society. It is rightly stated by the economists that the non-profit sector provides an excellent outlet for a variety of society's labour and skills. In the United States, approximately 10% of GDP is attributable to this sector. In India, however, the established pillars do not consciously pave way for the non-government sector to prosper.

What we advocate is the voluntary not for profit sector. Often the governments (State as well Centre) in India are susceptible of role and contribution of this sector. We need to make it very clear. Other than the government, all initiatives can be/ are termed as voluntary or non-government. Broadly the NGOs are termed as charitable organisations, social service organisations, developmental organisations and activist organisations. Each kind of organisation has its own objectives and the strategies to achieve these objectives. Most of the social service/ developmental organisations have grassroots presence and are widely accepted as an arm of the

government extension machinery. The activist organisations have started playing the role of watch dogs to keep the bureaucracy on its toes. The advantage of the non-government sector is its wide reach and acceptability to the marginalised communities; the small & marginal farmers, land less, deprived women, scheduled castes & scheduled tribes, dalits, etc. The NGOs can act as an implementer, facilitator, trainer, researcher, advocates of rights, etc. As on today the country can boast of presence of NGOs almost in every corner of Nation. But unfortunately this is the most unorganised sector without any entry restriction. It is a standard practice for the politicians and bureaucrats to register voluntary organisations with vested interests. Another reason for mushrooming of voluntary organisations is the large scale unemployment status of the country youth. If, addressed properly this sector has a potential to provide large scale employment to both rural and urban youth.

The Centre for Advanced Research & Development (CARD) identifies itself as a development NGO working primarily on livelihoods issues in rural sector. CARD acts as a facilitator of development process along with capacity building approach. It also acts as a research organisation and occasionally advocates rights. CARD believes in mainstream development and acknowledges the role of government in the overall development and welfare. It understands the systematic limitations of the government and works as facilitator of development process. We have specialized in improving the existing delivery mechanism of the government by providing participatory soft skills. We believe in complementing the mainstream development process rather than competing with it so as to have a larger impact. The sustainability of this approach largely depends on the empowerment of the communities for participating at all levels and by demanding their entitlements, and at the same time by advocating that the government functionaries accept the change. This can only be achieved by bringing in attitudinal change, disseminating knowledge and by imbibing participatory skills amongst various development stakeholders. This is where an interface is required and NGOs can act as the interface.

We strongly advocate that the governments, both central and the states must recognise the role of non-government organisations in all spheres of development and creates policy environment to encourage voluntarism.

CARD Initiatives

Impact Assessment / Perception Studies

CARD specializes in conducting impact assessment and perception studies using both conventional and innovative research tools. In case of impact assessment studies for the programmes of Central Government the main objectives are to see the implementation of the programme as per the set guidelines, the overall impact of all the programmes on villages in general and on the population below poverty line in particular, the role of the Panchayati Raj institution in programme implementation and the survival of assets created under different schemes. The conventional survey tools are used for such studies but with innovation and adoption.

In case of research studies and perception studies modern tools like Micro Planning and Modified Quantified Participatory Assessment (MQPA) are extensively experimented.

Capacity Building

As a Capacity Building Organization CARD has given a new dimension by introducing need based and capacity based training modules. A series of psychological tests, motivational games, and participatory tools along with experience sharing are an integral part of these modules. CARD is

associated with World Bank supported DPRP, DPIP in Chhattisgarh and Madhya Pradesh for designing, developing and executing Basic training modules. Rajeev Gandhi Watershed Mission and DRDAs are our other partners. Core capacity building areas are; micro planning, participatory planning, team building & group concept. Presently CARD is associated with ADB supported WRD-CIDP project for capacity building of Water User Associations in Chhattisgarh.

- CARD provides grassroots training and infield handholding on group based participatory livelihood promotion enterprises. It specializes in dissemination of rural technologies.
- CARD as Resource agency for watershed management has facilitated capacity building programmes for the functionaries of eastern M.P districts.
- CARD runs skill centres (NSDC, PMKK, NULM, DDUGKY, etc) at various locations
- CARD is KRC with Jal Jeevan Mission, Gol for facilitating level-3 trainings

Policy Planning & Policy Advocacy

- Policy Planning is a new area of expertise where in CARD has made a beginning with Livestock Sector Review and Policy Development Process under SDC-IC-CALPI Programme in Chhattisgarh state. The policy development initiative focused on Capacity Development in Human and Institutional Development by Training and Exposure with particular emphasis on key stakeholders who are participants in the Sector Review and Policy Development process. The assignment (2006-09) aimed at producing Sector study/Situation analysis of the Livestock Sector in Chhattisgarh and Development of a Perspective Livestock Development plan along with the new Policy Document.
- CARD has been addressing the issue of Governance under the Poorest Areas Civil Societies Initiative in a selected village cluster in eastern region (2003-08). The organization is committed to empower the local communities in accessing the development programmes of the Government.

Field Facilitation

CARD started its field operations by experimenting direct action for livelihood promotion in three distinct regions of Madhya Pradesh during the period 2000-2010:

- Poverty initiatives in areas where there is high incidence of poverty among scheduled castes and backward classes in feudal Malwa region (Ujjain, Shajapur, Dewas). The CARD team facilitated the process of empowerment of Common Interest Groups (CIGs/SHGs) village institutions (Cooperatives and VDCs) of marginalized communities in entrepreneurship development / livelihood promotion through self-help and farm sector development. To facilitate this Centre has been working in partnership with World Bank, Department of Science & Technology, Government of India, ICRISAT, Department of Agriculture and National Dairy Development Board. CARD has also mobilized CSR support from GAIL, IOCL, ITC and Suzlon.
- Drought Mitigation experiment on Watershed Management guidelines was intervened in Bhil tribe dominated Jhabua and Dhar districts of Western MP region, which is continuously facing the onslaught of desertification. For the purpose programme was facilitated under Rajiv Gandhi Watershed Development and Management Mission (MP). Other initiative in this region was CCF, India supported Child Development project, which focused on child centered community development.

- The eastern region of Madhya Pradesh (Mandla and Dindori) is rich in natural resources and inhabited largely by Gond tribe. Here CARD is actively involved in value addition to the local non-timber forest produce, through the self-help groups. Some of the Technology Management Packages (Honey, Natural Fiber, medicinal plants conservation and food processing) have drawn regional/national recognition. Here we have partnership with Canada Fund for Local Initiatives, Toyota Foundation (Japan), UNDP, TRIFED, SDTT, MKSP and Tejaswani.

After gaining learnings from these distinct experiments CARD started long term field operations and as on today we work on around 27 locations across MP, CG, Haryana, Punjab, Maharashtra and Uttar Pradesh with support from Government and Corporates.

Thematic Areas of Field Work

CARD believes in mainstream development approach and recognizes the role of State in overall development of the rural communities. We have specialized in improving the existing delivery mechanism of the government by providing participatory soft skills. In addition we specialize in conducting monitoring, evaluation and survey studies, as well as in building capacities of field level functionaries. CARD has a strong grassroots presence in some distinct regions of Central India, namely; Gond predominant eastern tribal region (MP & CG), agriculturally rich Feudal Malwa region and Bhil predominant western tribal region and Bundelkhand region where we demonstrate by doing. The Main fields of our action research/ field facilitation activities include:

Entrepreneurship Development / Skilling India

The number of people who enter the 'work force age group' every year in the country is estimated to be 26.14 million. Thus, it can be seen that 104.62 million fresh entrants to the workforce over next seven years (by 2022) will need to be skilled. In addition, 298.25 million of existing farm and non-farm sector workforce will need to be skilled, reskilled and up skilled. Therefore, to create an ecosystem of empowerment by Skilling on a large Scale at Speed with high Standards and to promote a culture of innovation based entrepreneurship which can generate wealth and employment so as to ensure Sustainable livelihoods for all citizens in the country, CARD contributes to the Nation Building by supporting the Government of India in its ambitious schemes of PMKK and ACABC.

Pardhan Mantari Kaushal Kendras: CARD has started 5 PMKKs in Chhindwara, Balaghat, Dindori, Mandla and Ujjain. CARD has offered its trainees 11 courses under Agriculture, Apparel, IT, construction, health care and security, and has completed training of over 15000 persons.

Agri-Clinic Agri-Business Centre Scheme: The Ministry of Agriculture and Farmers Welfare, Government of India, in association with NABARD and MANAGE has been providing training to eligible candidates, through Nodal Training Institutes (NTIs) and motivating them for setting up of Agri- Clinics and Agri-Business Centres. The scheme of ACAB aims to supplement efforts of public extension by providing extension and other services to the farmers on payment basis or free of cost as per business model of agri-entrepreneurs, local needs and affordability of target group of farmers, and to support agricultural development. CARD has been running as Nodal Training Institute in Bhopal and has completed 20 courses with more than 600 students completing the training.

NULM: CARD has been allotted targets of over 1000 trainees from its centres in MP (Mandla, Dindori, Balaghat, Chhindwara) and Kanpur and Aligarh in UP.

DDUGKY: CARD has been allotted target of 600 tribal trainees under the traits of DEO and Health care.

In all, CARD has been allotted total training target of over 23 thousand, out of which it has trained over 19 thousand and has successfully placed over 12000 trainees either under job or in self-employment.

Watershed Rehabilitation

The State of Madhya Pradesh took a lead in the watershed based development approach during the nineties when the common watershed guidelines were introduced at the National level. The key founders of CARD were among the few State level celebrities who shaped this movement. The CARD therefore inherited its legacy of land and water based livelihood development model. The execution of watershed rehabilitation programme could start only in 2002 under Rajiv Gandhi Watershed Mission with watershed plus approach and within a decade CARD has attained a position of one of the few agencies in India with experience of over 1 lakh ha area under watershed rehabilitation.

CARD also contributed towards shaping the new common guidelines through the findings/recommendations of several impact assessment studies commissioned by the GoI-MoRD, MP Govt and UNICEF and by representation of its Chief Functionary in the sub committees of the MoRD and as member of SLNA the during the early 2000s. We have been working in different agro climatic sub zones of Malwa, Western MP hills, Central Narmada Valley, Mahakaushal regions in the districts of Mandla, Jhabua, Dhar, Agar, Shajapur, Dewas, Dindori, Hoshangabad, Harda (MP), Dhamatari and Kanker (CG) in partnership of NREGS, IWMP, MPRLP, NABARD, NVDA, SUZLON, etc. CARD has also been a network partner with IWMP and FAO for promoting agriculture water management across the state. CARD has been facilitating NRM works under MGNREGA through CFT support programme.

Sustainable Agriculture/ Responsible Farming

Despite the fact that CARD has been a major player for rural livelihoods promotion through natural resource management since its inception, agriculture was never a prime focus rather it was taken up only as part of integrated development. The realization was soon brought into action by integrating with few national and international agriculture development initiatives. Today CARD is working with 30000 farmers on agriculture transformation through Good Agriculture Practices in 300 plus villages across Madhya Pradesh and Chhattisgarh and our motto is “Aap Cheti aap Khet” – “Sensible Farmer Responsible Farming”. We are presently active in two major practices in the state; one is the farmer support programme through responsible farming practices in Soybeans cultivation in the Malwa region, and the other is promoting chemical free natural farming in the Eastern Mahakaushal region.

CARD has been promoting capacity building of farmers, demonstration of new crop varieties and conservation of traditional varieties, farmer field school, primary & secondary agro processing, market network, etc. The major CARD initiative of Mahila Kisan Sashaktikaran Pariyojana (MoRD) is bringing the traditional agriculture labourer woman to the forefront as “responsible farmer-Sachet Mahila Kisan”. The other major supporter is the SDTT. CARD has promoted agriculture water management technologies across the state with FAO and IWMI support, and has been

instrumental in rehabilitation of more than hundred thousand hectares of individual and common lands with support from IWMP, NREGA, NVDA, NABARD, etc. Now CARD is mobilizing CSR funds for its agriculture development programmes.

Woman Empowerment

CARD has been consciously promoting the exercise of rights of women in decision making in general. If we look into the tasks of women in the agriculture operations across the Central India rural belt and their roles in the decision making process of these tasks. CARD further probed the reasons for the non-inclusion of women in the higher level decision making processes in agriculture operations and the psychology behind these decisions. The outcome of the brain storming exercise showed that; convention, illiteracy and poverty, inability to handle money/ household budget, lack of opportunity to understand market and unfriendly environment were the reasons. The suggestive measures are being taken care during preparation of training modules and capacity building programmes for the community (both males & females). Accordingly woman empowerment initiatives are being carried out in all field areas of CARD. CARD has facilitated 4600 rural women in 43 village federations with NDDDB support in Ujjain/ Shajapur and has more than 500 woman SHGs supported under Tejaswani and NABARD in Mandla; facilitating them in livelihoods promotion and gender activities. MKSP remains the major initiative in establishing the identity of women as farmers and also for promoting 500+ women as Community Resource Persons (CRPs). Partnering with E&Y, we undertook an initiative to strengthen 2500 women SHGs, impacting 27000 women. Our work ranging from capacity building and structural development to training and financial inclusion provides structural, operational and financial stability to the SHGs and community institutions leading to holistic development through women and empowerment. In all CARD has facilitated more than 5000 SHGs/ CIGs/ WTCS, etc.

Promotion of Farmers Producer Organisations

CARD started the initiative of promoting Farmer Producer Organisations in two blocks of Mandla district (Ghughari and Bichchiya) and two blocks of Dhar district (Badnawar and Dhar) with target of 1000 farmers for each FPO in partnership with Small Farmers Agri-Business Consortium (Ministry of Agriculture & Cooperation) during 2014. It is an initiative that ultimately aims at creating sustainable agriculture economy particularly for marginal and small farmers by consolidating their resources so that these cultivators may exploit economy of scales concerning agriculture practices, which, otherwise is not possible in view of small size of their holdings. The success of FPO model is yet debated, the old practitioners branding it as another green revolution while the critics say it is another SGSY. As it happens with all new initiatives there is mushrooming of FPOs being formed and not being able to cross its infancy stage. CARD has been mobilizing the farming community since a decade and now its decision to go for promoting FPOs will bring dividend soon. We are adopting area based different approaches in forming FPOs which can sustain without government aid. We have more than 10 registered FPOs and propose to have set up more than 20 FPOs by the end of 2018. We are also forming 4 women FPOs. Our sponsors include; SFAC, MKSP, NABARD, BIRD, etc.

Child Development

CARD has been working for total development of Bhil tribe Children in one thousand households in 18 villages of Tirla block of Dhar district with Child Fund India support since 2004. Health, nutrition, education, livelihoods and personality improvement are the main components of the development process. During the period most of the infants have grown up in to school children

and hundreds have crossed high school, three are few who are attending colleges. It is uncommon trend in this otherwise most backward Bhil tribe region. As part of total development we have organized three Child Resource Centers, four early care centers (Anganbaris), 22 child clubs, 17 orchards and have 22 active SHGs in these villages. The programme ended after 17 years in 2021, and now we are studying the impact of this decade long unique programme. But CARD has moved forward with the theme and has facilitated construction/ repair of more than 20 Anganwadis across India, most of which are as per ISO standard norms using CSR funds. We have also facilitated more than 30 Smart classes in government schools across MP, UP, Punjab and Maharashtra.

Water and Sanitation

CARD has partnered with GAIL, UNICEF and WFP for Water & Sanitation and has also facilitated wat-san models in various villages of Ujjain, Jhabua, Mandla districts of MP. CARD is national level verification agency for Nirmal Gram Puskar, and has facilitated in building capacities of staff of Water & Sanitation Department, GoMP. CARD helped UNICEF in establishing 21 “WWM models” and convinced the TWD and PHED to replicate WWM systems in 400 hostels across Madhya Pradesh. CARD supported UNICEF in 50 schools in Shivpuri district under the Fit for School programme (WASH) and supporting WaterAid in Chhattarpur, Panna and Damoh districts for WASH programme. Presently CARD and WaterAid are working on Woman+ water project in two districts of Dhar and Dewas since 2018. Women + Water Alliance, partnering with WaterAid India ensuring water security and water safety by improving water quality through regular water quality monitoring and motivating people to opt for water harvesting/conservation structures at the local level. CARD, through this project, has trained over 1000 panchayat representatives and village volunteers formed and strengthened village water and sanitation committees in more than 400 villages, and impacted over 3,00,000 people in Dhar & Dewas.

Presently, we are also helping the departments in the successful implementation of Jal Jeevan Mission - a flagship scheme of the central government, Ministry of Drinking Water and Sanitation through the preparation of Village Action Plans by community participation in these districts. CARD is associated with JJM as Key Resource Centre for capacity building in Dhar and Dindori (MP) and Rajnandgaon (CG).

Health and Life Skill Development

CARD is emerging a major player in the Health Sector with National Aids Control Organisation (NACO) supported projects; i) Link Workers Scheme (LWS); State level Lead Agency in Chhattisgarh State and District level Implementation Agency in Ujjain district, ii) Target Intervention with Female Sex Workers (FSW) in Bhopal. The main purpose is to spread awareness and information about HIV/AIDS; Reducing stigma and discrimination, care & support, etc. Integrated health and nutritional management program covering around a thousand households is also run in Dhar, and also organize health camps under various programmes in all locations.. CARD along-with National Health Mission, is involved in RKSK in 9 development blocks of Mandla district. CARD has a team of 2500 peer educators- Saathiyas, 38 master trainers, and 10 counsellors who are active in all the community health centers and district hospitals of the Mandla district and do counselling and follow up on the health of the adolescents. The team works in close to 1225 villages of the Mandla District.

NTFP based Rural Technologies

CARD has been actively involved in livelihood promotion of tribals and in organising tribals collectives. It has been promoting scientific harvesting, domestication and propagation, value addition and Marketing of some important NTFPs on eco-friendly basis for the past several years.

It has setup a technology resource centre (TRC) in backward tribal block of Ghughari in Mandla district and has successfully piloted GOI-DST approved TMPs in Honey, Sisal, NTFP, Medicinal Plant Processing and forest Nursery during 2001. Need and market research based

Technology Management Packages (TMP) were developed and field-tested to generate employment and sustained livelihoods for the rural tribals and approved by the Department of Science & Technology, Government of India. The TMPs were; Eco friendly Honey Harvesting & Scientific Processing, Medicinal Plant Semi-processing, Low Cost Nursery, Organic Composting, Natural Fiber Processing, and Processing of Locally available Food Products, CARD is working on promoting these NTFP based livelihoods in the region. The TRC (Technology Resource Centre) provides training and hand holding support to tribal NTFP collectors and also serve as processing centre.

Maikal Hills Natural Products

The society Centre for Advanced Research & Development has promoted setting up of “Maikal Hills Natural Products” a non-profit company registered under section 25 of Companies Act, 1956. The company was registered during 2005. The Maikal Hills Natural Products has set up following objectives:

- The first step towards empowerment of the CIGs is linking them up with livelihood options.
- Further the activities have to attain the level of sustainability, which is possible by way of establishing forward and backward linkages.
- The sustenance of activities will encompass capacity building of the group members, in selection of activities to its processing, etc.
- Market information here plays an important role, and this specialized area will require services of professionals who will assess the local potential and the local as well as outside demand, and accordingly will formulate strategies.
- Establish satellite units of product special SHGs/CIGs and Federations and link up satellite units with the Maikal Hills Natural Products.

The proposed plans to initiate at the inception of the “Maikal Hills Natural Products” are to establish, maintain and strengthen the activities, which are enlisted as under:

- Establishment of a Value addition cum production centre for all Medicinal products available naturally in the region, Natural Fiber products available in the region.
- Establishment of a Food Processing centre for production of vegetable, drinks, beverages, juices, jams, squashes, pickles and all type of edible oils, from locally available natural food products.
- Establishment of value addition centre for grading and marketing of forest/medicinal honey.
- Establishment of Non Timber Forest Produce, processing and value addition centre.
- Promote the Biodiversity conservation efforts in the region and promote Non-Conventional Energy sources.
- To set up a Market Research cum Information Centre to support the activities of ‘Maikal Hills Natural Products’.

Training Infrastructure

CARD started doing short duration trainings of up to one week in most of its locations very early. It uses both own as well as rented facilities. Our major Training centers are at Bhopal, Ujjain, Dhar, Dewas, Mandla, Dindori, Balaghat, Chhindwara in MP and Raipur in CG.

The facilities in MP include;

Bhopal: Own four storied building in posh locality (Arvind Vihar) built up area of 12000 sq ft on 5600 sq ft plot. There are two halls (30x26 and 40x25) and conference room (30x15) and three guest houses and 10 dormitories to accommodate up to 40 persons. Have own mess facility and dining apace as well. Separate rented stay arrangements are made for 60 participants in nearby hired location.

Have 3 sets of LCD/ OHP, 12 computers and ten laptops, printers, xerox and other training requisites.

Ghughari in Mandla: A scenic location in remote area near Mandla and the CARD campus is spread up in 6.5 acres of agriculture field where demonstration plots are laid. CARD has been regularly conducting in-house residential trainings here since 2010. We have constructed permanent eco-friendly Training Center to accommodate up to 150 persons for long durations with Mess, dining and recreation spaces. There are 2 tube wells, Well, pond, etc. Also have five sets of LCD, OHP, 45 computers and five laptops and other training requisites, including Gen Set (30 KV).

Also have one Technology Resource Centre with DST approved training Techno- Management packages in Honey, NTFP processing, Food Processing, Nursery and Natural Fiber (Seasal). Have a Training Centre for up to 30 participants just on the river bank. Regular short duration on the job trainings are being organized here.

Dhar: CARD has own office (10000 sq ft plot area) in Dhar and has small training infrastructure and is regularly conducting trainings of children, students, parents, guruji, health workers, panchayats, etc.

Dindori: CARD has own office on the banks of Narbada, a plot of 4000 sqft with 10000 sqft built-up area and runs regular skill trainings of NSDC like PMKK and NULM.

CARD runs five PMKKs- a state of art training infrastructure in **Balaghat, Chhindwara, Mandla** and **Ujjain** spread over more than 10000 sqft built-up area each, with 10 halls and rooms where five continuous batches can be run. PMKK Dindori is run from own premises and the remaining 4 are run in hired premises.

In other CARD locations as well hired facilities are used as per need.

Management & Faculty

The management of CARD is in the hands of committed professionals who make an interesting mix of youthful experience. The faculty of CARD consists of experts from varied fields. Besides the mainstream committed workers of voluntary experience they include government officials, academicians, and enterprising individuals in private institutions.
